# MINUTES OF THE NC LIONS MD-31 PROMOTIONS COMMITTEE MEETING 1:15 PM, SATURDAY, AUGUST 15, 2015 GREENSBORO AIRPORT MARRIOTT, GREENSBORO, NC

The MD-31 Lions Promotions Committee met at the Greensboro Airport Marriott, Greensboro, NC, Saturday, August 15, 2015. Those attending were: Governors Debbie Hicks, Allen Reinhardt, Randall Clapp, Vince Schimmoller and Mary Boehm; also 1<sup>st</sup> VDG's Max Bumgardner and Irwin Siegelwax, and PDG's Jana Peedin and Ron Beltran. Chairman and PDG Chris Headley presided.

Members absent were PDG's Will Hicks, F.L. "Doc" Shaver and Carol Weeks.

Chairman Headley called the meeting to order and asked Governor Boehm to offer the invocation. Governor Reinhardt led the pledge to the American Flag.

Chairman Headley welcomed the audience and asked for approval of the agenda. Upon motion of Governor Reinhardt with second by Governor Hicks the agenda was unanimously approved.

Chairman Headley recognized members of the Lions International Family and asked if there were any remarks. PID Harvey Whitley thanked PDG Terry Cauble for his efforts to organize a successful reception and North Carolina Lions Breakfast at the International Convention in Hawaii. He also thanked Lions Robin and Corey Cauble for their assistance and labors.

PDG Dave Butler was appointed Parliamentarian.

The report of the 2014-2015 Promotions Committee Chair, PDG Terry Cauble, followed. He reported that 78 North Carolina Lions and guests attended the International Convention. He noted that 50 persons attended the Sunday morning NC Lions Breakfast with a steady string of candidates for International office appearing to introduce themselves and ask for North Carolina's support.

PDG Cauble reported that there are 233 items remaining in the Lions apparel inventory at year's end.

Upon motion of PDG Beltran, second by PDG Peedin, the vote was unanimous to approve the Minutes of the May 2, 2015, Promotions Committee Meeting.

Secretary-Treasurer Rhett White reviewed the 2014-2015 Year End Promotions Financial Report. He noted that income exceeded expectations by \$1,184.97 and that sales of merchandise were exceptional. He reported \$20,957.30 in the checking account, \$6,168.00 in clothing inventory and \$5,817.74 in the promotions money market account for assets totaling \$32,943.04.

### Upon motion of Governor Reinhardt and second by Governor Boehm, the year-end financial report was unanimously accepted and will be sent to the auditor.

The Treasurer presented the proposed 2015-2016 Promotions Committee Budget. He explained that he and the committee chairman had discussed several items in the budget including one new imitative – the Novant Health Thanksgiving Parade. He explained that the proposed budget totals \$25,606.00 with income from dues down about \$500.00 from last year due to declining membership. He also noted that State pin sales are declining with the drop in membership.

Motion was made by Governor Schimmoller with second by Governor Hicks to adopt the budget as presented.

Discussion followed.

PIP Sid Scruggs suggested changing the budget line for S.E. Breakfast to North Carolina Breakfast. Much discussion followed about the S.E. Breakfast at the Hawaii convention which was not publicized until a few days prior to the convention, and that was not attended by any Lions from North Carolina. The consensus was to establish a tradition of a North Carolina Breakfast, but that North Carolina does need to be represented at any southeast regional breakfast.

The proposal to budget \$500 for the Novant Thanksgiving Day Parade in Charlotte was also the subject of much discussion. PDG Dave Butler pointed out that the Promotions Committee is charged with promotion North Carolina on the International scale, not within the state or locally.

Motion was made by Governor Schimmoller, second by Governor Hicks, to call the vote. The motion passed unanimously.

The vote on the original motion to adopt the budget as presented was defeated by a vote of three (3) in favor and six (6) opposed.

PDG Beltran made a motion, seconded by Governor Hicks, to adopt the proposed budget with the S.E. Breakfast line item renamed the International Convention Breakfast, and that any funding for the Novant Thanksgiving Day Parade be excluded as the parade is a local event. Adoption of the 2015-2016 Budget with changes noted was unanimous.

### attachment # 5

Chairman Headley urged Lions to attend the September 17-19, 2015, USA/Canada Forum in Grand Rapids, Michigan. He noted that several North Carolina Lions are involved in planning the event and others will serve as presenters and moderators.

He also said it is not too early to begin planning to attend the 2016 Lions International Convention in Fukuoka, Japan, June 24-28, 2016. He said hotels have been assigned.

Discussion on design of the 2016-2017 State Trading Pin followed under the direction of PDG Butler. He discussed several possibilities including a large bird pin for the 2017 Centennial Anniversary of Lionism. Lion Dale Dupree suggested a Centennial Pin with the North Carolina background to include an Uncle Sam Lion. PIP Scruggs noted it is important to have the convention sites on our state trading pins.

PID Lacey Presnell said the 2017 International Convention in Chicago is a "big deal" so our pin for that year should be a big deal. Upon motion of Governor Reinhardt and second by Governor Hicks, the vote was unanimous to designate a committee to work on a 2017 State Pin design and have it ready for consideration at the November meeting of the Promotions Committee. The committee includes the five District Governors, LCI Centennial Coordinator Gwen White and PDG's Dave Butler and Dale Dupree.

PDG Butler reminded the council that a February pin order will be placed for those attending the International Convention in June.

First VDG Max Bumgardner reported on the Pisgah High School Marching Band that is raising funds to participate in the Lions International Centennial Parade in Chicago. He said the band must raise \$60,000.00 for the trip and that Lions will be hearing more about this band as the year goes on.

Upon motion of 1<sup>st</sup> VDG Bumgardner, second by Governor Schimmoller, the vote was unanimous to donate \$500.00 to the band's fundraising effort.

A new parade uniform for 2017 was discussed. PID Whitley said a new and special uniform should be used at the Centennial Convention. Governor Reinhardt suggested getting ideas from Lions across the state and to get them to Gwen White.

The uniform for the convention in Japan will be the same one used for several recent years.

With no additional business, Chairman Headley asked Governor Boehm to dismiss the meeting with the benediction. Chairman Headley adjourned the meeting.

# MINUTES OF THE NC LIONS MD-31 PROMOTIONS COMMITTEE MEETING 1:PM, SATURDAY, MAY 2, 2015 HOLIDAY INN, WILMINGTON, NC

The MD-31 Lions Promotions Committee met at the Holiday Inn, Market Street, Wilmington, NC, Saturday, May 2, 2015. Those attending were Governors Dave Titus, Sharron Weddington, Norma Jean McKinney, Chris Headley, Lynn McCaskill, Ron Beltran, Carol Weeks and Jana Underwood Peedin; also PDG Vince Schimmoler, 1<sup>st</sup> VDG Mary Boehm and Council Chair Ron Kelly. PDG and Chairman Terry Cauble presided.

Chairman Cauble called the meeting to order and asked Governor McCaskill to offer the invocation. Governor Peedin led in the pledge to the American Flag.

After welcoming those attending, Chairman Cauble presented the agenda for approval. Upon motion of Governor McCaskill, second by Governor Peedin, the vote was unanimous to approve the agenda.

Chairman Cauble recognized the International Family.

PDG Tim Williams was appointed Parliamentarian.

Secretary-Treasurer Rhett White presented the minutes of the February 7, 2015, Promotions Committee Meeting. Upon motion of Governor Titus, second by Governor McKinney, the minutes were unanimously approved as presented.

The financial report covering the period from July 1, 2014 to April 29, 2015, was presented by Secretary-Treasurer White. He reported that revenues are about \$2,000.00 below budget but should catch up by June 30<sup>th</sup>. He noted that expenditures are well below budget. Upon motion of Governor Headley with second by Governor Titus, the financial report was unanimously accepted as presented.

Chairman Cauble reported that 78 persons are registered to represent North Carolina at the 2015 Lions International Convention in Honolulu, Hawaii, June 26-30. He said the North Carolina hotel (Courtyard by Marriott Waikiki Beach) is about one mile from the convention center. He reminded those planning to march in the International Parade, that line-up is at 9:AM, Saturday and the parade uniform is red vest, white shirt, black slacks or skirt, white shoes and white cap or panama hat optional.

Chairman Cauble urged Lions to take advantage of the early registration price. He announced that the North Carolina Breakfast will be at the Spada Restaurant in the convention hotel at 7:AM, Sunday morning. There will be space for 64 persons with a \$15.00 charge for the buffet.

PIP Sid Scruggs advised those attending to use this as an opportunity for North Carolina Lions to get together and fellowship rather than invite candidates for international offices to attend.

Chairman Cauble asked PID Harvey Whitley to report on the September 17-19, 2015, USA/CANADA Lions Forum in Grand Rapids, Michigan. He thanked PDG Paul Bledsoe for his help on the planning committee and in handling with the media for the 7<sup>th</sup> year He noted that several North Carolina Lions will serve as presenters or moderators.

PID Whitley said the early registration ends June 1<sup>st</sup> and announced that Lions age 30 or younger get a discount registration rate. He said four meals are covered in the registration fee. He also said additional session have been added for Thursday.

Chairman Cauble reported on clothing sales from August through the Sate Convention. He said the inventory as of April 29, 2015, was valued at \$6,389.00 attachment # 4

Under Unfinished Business, Chairman Cauble reported that 44 of the 50-year plus pins were presented at the NC Lions State Convention. He said the remainder will be mailed directly to the recipient with a letter of congratulations. He said another letter will go to the club announcing the award and encouraging a special presentation. Upon motion of Governor McKinney with second by Governor Peedin, the vote was unanimous to endorse the method of distribution of the remaining pins.

PIP Scruggs thanked Chairman Cauble for his work to make the special recognitions possible.

Chairman Cauble thanked the Lions of North Carolina for allowing him to serve as Promotions Committee Chairperson. He announced that Governor Headley will assume the Chairmanship July 1, 2015.

Governor Headley said he plans to implement a system to accept credit cards next year, probably using the "Square" system.

PDG Dave Butler reported that the initial order of 2015-2016 North Carolina trading pins have been ordered. A second order will occur in February for those attending the International Convention. He said proposals are needed by August for a new pin,

encouraging anyone submitting designs for consideration to use a subject that is appropriate for the entire state.

Some discussion followed on the need for a centennial pin for 2016-17 and another for 2017-18. There were suggestions to highlight Camp Dogwood and the VIP Fishing Tournament.

Chairman Cauble announced a meeting for the four of five in-coming Governors in attendance. The subject was the International Convention.

After the benediction by Governor McCaskill, Chairman Cauble adjourned the meeting.

## MINUTES OF THE NC LIONS MD-31 PROMOTIONS COMMITTEE MEETING 1:PM, SATURDAY, FEBRUARY 7, 2015 CROWN PLAZA, CHARLOTTE, NC

The MD-31 Lions Promotions Committee met at the Crown Plaza, Charlotte, NC, at 1:PM, Saturday, February 7, 2015. Those attending were Governors: Dave Titus, Sharron Weddington, Norma Jean McKinney, Chris Headley, Lynn McCaskill, Ron Beltran, Carol Weeks and Jana Underwood Peedin; also PDG Will Hicks, Vince Schimmoller, Mary Boehm and Council Chair Ron Kelly. PDG and Chairman Terry Cauble presided.

Those absent were Lion Charles Mann, PDGs Terrie Grooms, Sandy Scarlett and Mike Elmore.

Chairman Cauble called the meeting to order and welcomed the audience. He asked Governor McCaskill to offer the invocation and Governor Headley to lead the Pledge of Allegiance to the American flag.

Upon motion of Governor Titus, second by Governor Weddington, the vote was unanimous to approve the agenda.

Chairman Cauble recognized PIP Sid Scrugg, PID Harvey Whitley and PID Lacey Presnell and thanked them for their attendance, support and advice.

PDG Charles Holloman was appointed Parliamentarian.

Upon motion of Governor Peedin and second by Governor McKinney, the Minutes of the November 8, 2014, Promotions Committee Meeting were unanimously approved attachment # 2

Secretary-Treasurer Rhett White reviewed the financial transactions from July 1, 2014 through February 4, 2015. He reported that income exceeds expenditures and noted that some funds will be moved into the Money Market Account since there is more than ample funds in the checking account for committee operations.

Upon motion of Governor Peedin, seconded by DGE Mary Boehm, the vote was unanimous to accept the financial report as presented.

### attachment # 3

Chairman Cauble reviewed details about the 2015 Lions International Convention in Honolulu, Hawaii, June 26-30. He noted that 57 North Carolina Lions have already registered with the number expected to grow. He urged Lions to take advantage of the early registration rate of \$150 through March 31<sup>st</sup>. He reminded Lions that the North Carolina hotel is approximately one-mile from the Convention Center.

Discussion followed on the Southeast Lions Breakfast. Neither Chairman Cauble nor Council Chair Ron Kelly have received any information on the breakfast which should be hosted by the Lions of Florida this year. Several Lions indicated they would rather have a North Carolina Breakfast so members of the delegation can get together at least once during the convention. This sentiment was voiced by PID Scruggs and PID Presnell.

By motion of Governor McKinney with second by Governor McCaskill and unanimous vote, the Promotions Committee directed the Committee Chair to let the Southeast Breakfast Coordinator know that North Carolina does not plan to participate in the breakfast.

Chairman Cauble reported sales of \$608 at the District 31-B Convention, \$1,420 at 31-A, \$1,282 at 31-G,H&J, \$620 at 31-E and \$460 at 31-F. He reported clothing sales of \$373 at the August Council Meeting and \$380 at the November Council Meeting. He said the merchandise inventory as of November 4, 2015, was valued at \$9,107.50.

It is noted that 551 patches used in the promotion of the Sid Scruggs candidacy for Lions International President have been removed from inventory and given to the VIP Fishing Tournament, Inc., for distribution.

The Chairman submitted a copy of the Promotions Committee Report for the record.

Unfinished Business included discussion on a 50-year plus pin for senior Lions who have maintained membership for 50 or more years, a proposal to recognize long-serving Lions that was presented in August by PIP Sid Scruggs. PIP Scruggs reviewed his desire and efforts to get proper recognition for these Lions.

After discussion, it was decided that this is an appropriate promotional project for the Promotions Committee. Upon motion of Governor Weddington, second by Governor McKinney, the vote was unanimous to purchase 350 pins at \$1.40 each.

Governor Headley reported on the Novant Health Thanksgiving Day Parade in Charlotte, explaining the it provided valuable publicity for the Lions of North Carolina.

PDG Dave Butler noted that the eight districts ordered 2,350 trading pins last year with this year's number under 2,000 pins. He noted there will be a February order for those going to the 2016 Lions International Convention.

PDG Butler announced that the next pin will be the fifth in the bird series and invited Lions to consider submitting any design they would like for consideration next year.

Chairman Cauble announced a 2:PM meeting with the incoming District Governors. PDG Gwen White spoke about the value of participation at the International level which she said is extremely important, citing the Lions Clubs float in the Rose Bowl Parade that featured five sports challenges for the blind including the VIP Fishing Tournament.
