New Brighter Visions Campaign Starts July 1

District Governors Set Minimum Goal Of \$583,560 For 2019-2020

District governors in Multiple District 31 have pledged to raise a minimum of \$583,560 for the 2019-2020 Brighter Visions Campaign.

Contributions benefit the programs and services provided by North Carolina Lions, Inc., our state's charitable organization.

Brighter Visions money makes up 49.2-percent of the NCLI budget. It supports Camp Dogwood, the matching funds program, mobility canes, educational grants, the deaf-blind retreat, the mobile screening unit, low vision aids, health education programs, organ and tissue procurement, and our state's recycling program.

District governors establish a minimum per member goal for clubs in their respective districts.

Contributions can come from clubs, individuals and the business community. The annual campaign kicked off on July 1 and ends on June 30.

Matching Funds Program Relies On Fundraising

Matching Funds is a North Carolina Lions, Inc. program that can assist Lions clubs in Multiple District 31 to help North Carolina residents who have a financial need with eye exams and eyeglasses.

The program also can help the blind and visually impaired with a monetary grant that can be used to pay for medical procedures, low vision equipment and software, and prosthetic eyes.

NCLI has \$65,000 in the 2019-2020 budget. Payments will be made as long as there is money in the fund. Contribut-

ions to Brighter Visions goes to Matching Funds.

Under the standard program, clubs can be reimbursed 50-percent of their payment for an eye exam and eyeglasses, up to a maximum of \$100.

Grants range from \$600 to \$1,250, depending on the service provided. Grants requests must be preapproved by the NCLI Executive Board with services provided within 90 days of approval.

BV Campaign State Chairperson Says 100-Percent Participation Is Possible

The 2019-2020 Brighter Visions Campaign has kicked off with a goal of raising \$583,560 for North Carolina Lions, Inc.

I would like to thank every district, club and member who made a contribution last year. While we were short of our 2018-2019 fundraising goal, we still raised a lot of money for NCLI.

This year the committee has a lofty goal of attaining 100-percent participation of clubs in Multiple District 31. Every North Carolina Lion is a member of NCLI and our state organization deserves our support.

The programs and services provided by NCLI benefits the people of our state. But in order to continue the level of service we have come to expect from our charitable organization we must raise the money needed to fund our programs, such as Camp Dogwood.

As of last year's deadline, 45 clubs in the multiple district had failed to contribute one dollar to the campaign. Yet, almost all of these clubs are located in a county which received a direct benefit from NCLI.

This year, I am asking our district chairpersons to concentrate their efforts on these zero clubs and encourage participation. Every dollar contributed to our Brighter Visions Campaign helps.

If a club cannot meet the district governor's minimum per member goal, the club can still make a contribution. Even members themselves can contribute with the credit going to the club.

NCLI Continues To Serve Despite Lower Contributions

Ninety-Two Counties In Multiple District 31 Directly Benefitted From The Brighter Visions Campaign

More than 6,000 people were served in 2018-2019, thanks to the programs and services offered by North Carolina Lions, Inc., our state's charitable organization.

Money contributed to NCLI through the Brighter Visions Campaign paid for a majority of the costs, despite lower than projected income from last year's fundraising.

The campaign is responsible for 49.2-percent of income needed to support NCLI.

Residents from 92 of the state's 100 counties received some sort of benefit from NCLI-funded programs, according to the organization. Last year, the cost to provide the services exceeded \$1 million.

Camp Dogwood, our recreational facility for the blind and visually impaired located in Catawba County, hosted 565 people from 81 counties in the state.

It costs the state organization approximately \$1,300 per person for a five-night stay at camp, most of which is raised through Brighter Visions.

Lions clubs in 45 counties in Multiple District 31 applied through the Matching Funds Program to NCLI for reimbursement of a portion of the cost of providing 746 eye exams and 895 glasses last year.

Under the Brighter Visionsfunded program, clubs can be reimbursed 50-percent of the cost, up to a maximum of \$100. The program also offers higher reimbursements for medical procedures, low vision equipment or prosthetic eyes.

More than 4,203 people received free vision screenings through use of the See the 21st Century Mobile Screening Unit, another service that receives most of its funding through the campaign. Clubs pay a fee to reserve the unit.

Lions clubs in 29 counties reserved the mobile screening unit last year for a total of 60 event.

Another campaign-funded program offered by NCLI is providing support and mobility canes to the blind and visually impaired. Last year, 274 canes were distributed in 62 counties



at a cost of more than \$8,000 to the organization.

Blind and visually impaired individuals can apply for a new cane every 24 months. First-time users must be evaluated by the Division of Services for the Blind before they can apply for a cane.

Three educational grants of \$1,500 per year were awarded by the NCLI last year through the campaign-funded program which is available to the sighted children of blind and visually impaired parent(s). Based on financial need, the program is renewable up to four years and the student must maintain a 2.0 GPA.

Ruth Haines knows firsthand the importance of the Brighter Visions Campaign.


Because of the money contributed to North Carolina Lions, Inc., the Asheville resident has been able to attend Camp Dogwood for 11 years.
